Appointment of senior official investigated: The Sunday Times reported that the Department of Correctional Services launched an investigation into the appointment of the Deputy Commissioner of Employee Relations. PRISON CONDITIONS

Poor education and rehabilitation facilities: Eye Witness News reported that education and rehabilitation facilities for young offenders in prison are inadequate. The report quotes Lukas Muntingh of the Civil Society Prison Reform Initiative saying "the inconsistency in the quality of service and retention conditions" were extremely troubling. Construction of prison facilities delayed: Eye Witness News reported that officials from the Departments of Public Works and Correctional Services informed the Portfolio Committee on Correctional Services that delays had intermittently stalled the construction of two prison facilities in the Western Cape. ESCAPES

Prison escapes declining: Times Live reported that the number of prisoners escaping from South African prisons has declined over the past decade. According to the Department of Correctional Services the highest number of prison escapes was 281 in 2002/3 and the least was 41 in 2011/12. CAMEROON

Death row prisoner takes care of fellow prisoners: Jade Cameroun reported that a prisoner on death row at Foumban Prison provides medical assistance to his fellow prisoners. He was reportedly one of the participants in a project by the German Development Agency that provided training, first aid and the early detection of HIV/AIDS and tuberculosis. Prison conditions desperate: Star Africa reported that a report recently released by Amnesty International details how the lives of prisoners in Chad are often put at risk by harsh conditions of detention, particularly severe overcrowding. The report also notes that in the past twelve months

DEMOCRATIC REPUBLIC OF CONGO

Unknown disease causes deaths in Bunia: Radio Okapi reported that an unknown disease was spreading in Bunia prison in the Oriental Province. In two weeks six prisoners reportedly died following symptoms of severe fever and coughing. The head of the prison's medical unit has pleaded for the transfer of critically ill prisoners to the city hospital for better quality medical care. Original report in French. Kasapa Prison holds more than 1000 awaiting trial prisoners: Radio Okapi reported that Kasapa Prison in Lubumbashi currently holds more than 1000 awaiting trial prisoners and 200 sentenced prisoners. Court appearance affected by lack of transport: Radio Okapi reported that due to the breakdown of the only prisoner transport vehicle, awaiting trial prisoners at Makala Prison in Kinshasa have not been able to attend court hearings for the past two months. Lawyers representing the prisoners have been pleading for a quick solution. Prison authorities blame the state for not ensuring access to sufficient appropriate vehicles. Original report in French. Released prisoners complain about detention conditions: Radio Okapi reported that two women and 19 men were released conditionally from prison in Beni. During the ceremony marking their release the prisoners denounced the conditions of their detention in front of officials of the penitentiary unit of MONUSCO. They further complained that some prisoners were held much longer than the period of their sentence and that others waited for months before appearing before a court. Original report in French. Prison director pleads for assistance: Radio Okapi reported that the Director of Mulunge Prison in Uvira called a press conference for the purpose of requesting humanitarian assistance for prisoners. The food received from the prison authorities reportedly fails to ensure even one meal per day, let alone the three meals to which prisoners are entitled by law. Original report in French. Prisoners on hunger strike: Ahram Online reported that twenty foreign nationals imprisoned at Cairo's Qanater Prison have gone on hunger strike in the hope of raising awareness of the extremely long sentences that they are currently serving. Most of the strikers were reportedly sentenced after having been convicted of drug-related offences, crimes which carry extremely harsh penalties. MOZAMBIQUE

Police told to remove prisoners from cells: allAfrica.com reported that Attorney-General Augusto Paulino informed the police that they could no longer keep prisoners serving sentences in the cells of the Maputo City Police Command and must transfer them to prisons. Of the 88 prisoners incarcerated at the police command cells, 44 are classified as dangerous prisoners, 25 are awaiting trial and 19 are serving lengthy prison sentences. Deadline to review cases given: allAfrica.com reported that on 21 September 2012 the Attorney-General gave all the prosecutors in Maputo a deadline of 15 days to review in detail all the cases involving the 864 prisoners currently incarcerated in the Maputo Top Security Prison. Of the 864 prisoners, 424 are said to be awaiting trial and in many cases the legal period for preventive detention has reportedly expired. Many inmates awaiting trial: Punch reported that 36 000 of the 50 000 inmates in Nigerian prisons are remand detainees. Prison overcrowding and poor conditions of detention: IRIN News reported that Togo's twelve prisons, most of which are dilapidated, are accommodating more than double the amount of prisoners for which they were designed. Overcrowding, as well as poor nutrition and hygiene and a lack of medical care have reportedly led to disease and death. The report states that lengthy court cases, arbitrary arrests and the detention of petty offenders are the cause of prison congestion.
