Paralegal case study in Rwanda: Penal Reform International has published a report documenting a pilot paralegal programme in Rwanda from 2009-2010. The project was launched for the purpose of developing paralegal services for detainees being held in prisons with the objective of reducing the high rate of pretrial detention. Commission for Social Development 50th Session: On 1 to 10 February 2012 the 50th session of the Commission for Social Development took place in New York. CAMEROON

Ten women detained on charges of homosexuality: The Daily Mail reported that ten women arrested in Cameroon on charges of being homosexual are being detained until their respective trials. Consensual same-gender sex is punishable by a prison sentence of between six months to five years. DEMOCRATIC REPUBLIC OF CONGO

Repatriated immigrants detained in prison: Radio Okapi reported that 52 Congolese men that had been deported from South Africa were then detained by Congolese authorities in Kasapa prison. The authorities reportedly insisted their detention was necessary for identification purposes. Original report in French. Justice system in need of reform: Voice of America reported that the country's justice system is in dire need of reform. A spokesperson from a human rights organisation based in the DRC stated that the justice system needs to be rebuilt "from the ground" as the system is "saddled with many problems, including dilapidated court houses and corruption among judges, prosecutors and lawyers." In addition, the report stated that there is a lack of capacity, transparency and accountability at all stages of pre-trial processes. Amnesty International reports on rampant torture in prisons: The Guardian reported that Amnesty International condemned the Libyan militias' use of torture against suspected Gaddafi loyalists who are reportedly being detained in prisons and secret places of detention all over the country. Police reforms underway: The Moment reported that newly appointed Inspector General of Police, Mohammed Dahiru Abubakar, was undertaking reforms, which, if strictly implemented and adhered to could repair the battered image of the Nigerian Police Force and enhance its professional responsibility. High number of remand detainees: Leadership Nigeria reported that the Deputy Controller of Prisons said that out of 898 prisoners at Onitsha prison, only 53 had been convicted and were serving their sentences. The remainder were remand detainees. The prison is reportedly severely overcrowded as it is only designed to accommodate 326 prisoners. SOUTH AFRICA

Intervention urged: The Saturday Star reported that the conditions under which rape victims were attended to at Umbilo police station "have not improved" despite an Independent Complaints Directorate investigation into 34 incidents of unconstitutional or inhumane treatment of victims of sexual offenses and a directive for the police to take corrective action. Zimbabwe to ratify UN Convention against torture: The Herald reported that the government had begun motivating for the formal ratification of the United Nations Convention against Torture and other Cruel, Inhuman or Degrading Treatment or Punishment. The report quotes the Minister of Justice as saying that "people who are alleged to have committed torture in Zimbabwe did not do it with the authority of their superiors." Allegations of torture in remand detention: The Daily News reported that despite assurances to the contrary by the Ministry of Justice, the use of torture "to extract evidence from suspects has become routine and systematic." The report added that it had become part of remand procedure for magistrates to ask suspects if they were tortured while in police detention.
