**Committee against Torture 50<sup>th</sup> Session:** The 50<sup>th</sup> session of the Committee against Torture took place from 6 – 31 May 2013 in Geneva. #### **ETHIOPIA**

**Journalists harassed and detained**: The Guardian published a feature article on the treatment of journalists by the Ethiopian government. It notes the 'heavy hand' the government uses to quell any form of dissent on the part of the media, in particular, its use of anti-terror legislation. The report features the details of a particular case wherein a journalist was sentenced to 18 years imprisonment for having written an article about the Arab Spring and "suggesting something similar could happen in his own country." # THE GAMBIA

**Critical report on prison:** allAfrica.com reported that President Jammeh was 'shocked upon reading a report on the State Central Prison Mile 2.' The report allegedly describes extremely harsh conditions, poor sanitation as well as notes the fact that there are remand detainees that have beeng detained for lengthy periods of time awaiting trial. # MALAWI

**Improving pretrial justice:** The Maravi Post reported that the University of Malawi, in collaboration with a number of South African organisations, was in the process of delivering specialised training to 100 justice officials, including magistrates and prosecutors. The training programme is aimed at addressing the gap between legislative provisions intended to curb issues like overcrowding and lengthy pretrial detention, and practice. # **SOUTH AFRICA**

Latest figures on overcrowding: eNCA reported that as of August 2013 there are just over 156 000 inmates in

correctional centres in South Africa, more than a quarter of whom are remand detainees. The Minister of Correctional Services reportedly stated that the Department was committed to reducing the level of overcrowding by at least two per cent per annum in order to comply with the constitutional requirement to detain inmates under humane conditions. Harassment of activist: allAfrica.com reported that an activist that has been trying to hold the police accountable in Khayelitsha appears to be a victim of police harassment. The activist, Ms Peters, has been repeatedly arrest on charges which, a magistrate stated, were 'highly improbably.' The report states that Ms Peters was released on bail, but that she will be back in court during October 2013. #### **TANZANIA**

**Provision of legal aid**: IPP Media reported that indigent citizens would be able to access legal assistance once a proposed bill comes into force. The Ministry of Justice and Constitutional Affairs reportedly intends to 'enact a law' that will entitle the country's poor to access legal aid in criminal and civil cases free of charge. The report notes that the proposed statute will provide for the establishment of a regulating body that will set standards for the provision of legal aid. **Detainees protest**: allAfrica.com reported that more than 300 inmates staged a protest by refusing to disembark from the bus transporting them from the prison to court. The inmates reportedly protested against the unnecessary prolonging of their trials and accused the Regional Police Commander of fabricating the charges against them. #### **TUNISIA**

Allegations of torture: allAfrica.com reported that Human Rights Watch have called on Tunisian authorities to open a prompt and thorough investigation into allegations of ill-treatment at Mornaguia prison. The allegations were reportedly made by two suspects who are being detained under the country's counter-terrorism legislation. Although the allegations were made in mid-August 2013, an investigation has not yet been initiated. #### **UGANDA**

**Prison overcrowding:** The Daily Monitor reported that Uganda is ninth among the top ten countries with most overcrowded prisons in the world. The report notes that the country's overcrowding is partly due to the inefficient criminal justice system, as almost 90 per cent of inmates are awaiting trial. **Overcrowding on the increase:** allAfrica.com reported that the prison population in northern Uganda has increased dramatically over the last two years. The report notes that the existing prison capacity for northern Uganda is 2 407 but the current population is currently at 6664. The report states that the reasons for the increase include the unnecessary extension of cases, common land disputes, domestic violence and assault. ### **ZAMBIA**

**Journalist released from custody:** allAfrica.com reported that a freelance journalist who was charged and detained in connection with his suspected links with the Zambian Watchdog, an online publication that is openly critical of the current government, was released after the Media Institute of Southern Africa (MISA) condemned his detention. The journalist was reportedly chained to his bed during his detention. #### **ZIMBABWE**

Activist dies in detention: allAfrica.com reported that an opposition party activist died in detention following a two-year period of detention awaiting trial.
