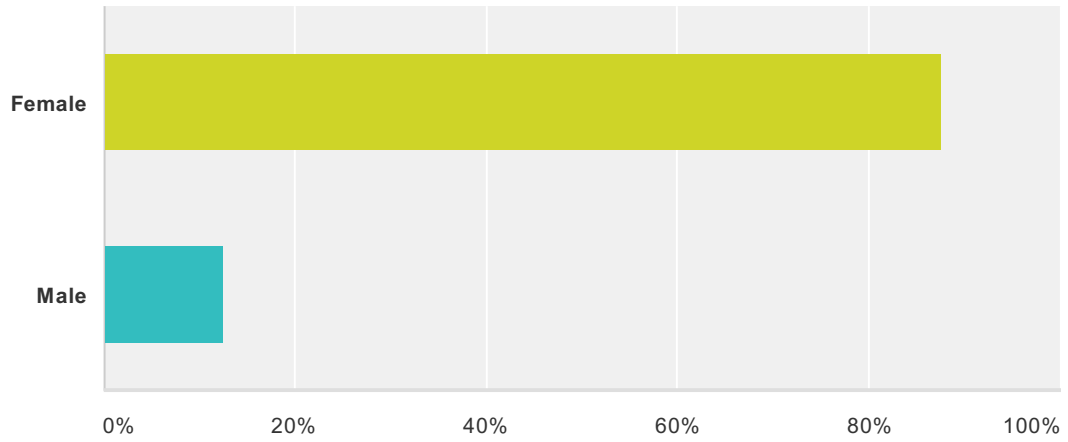

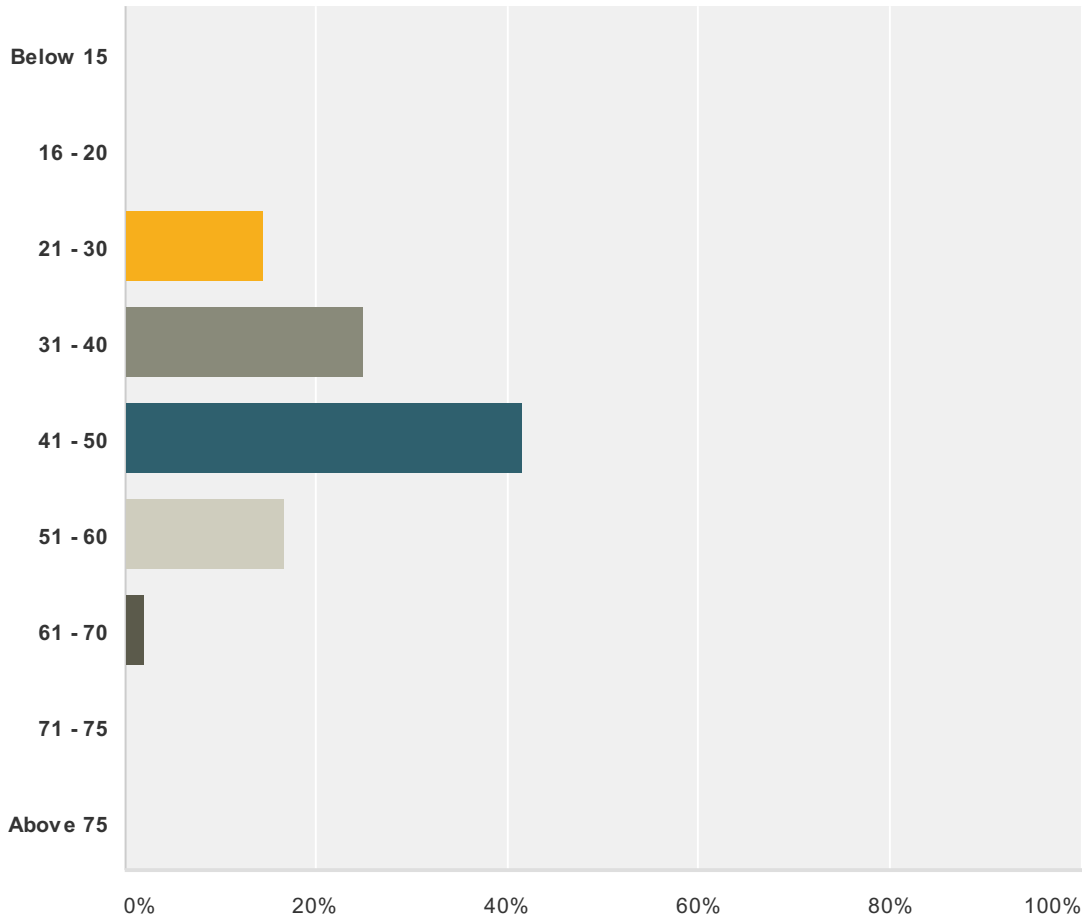

Q2 How old are you?

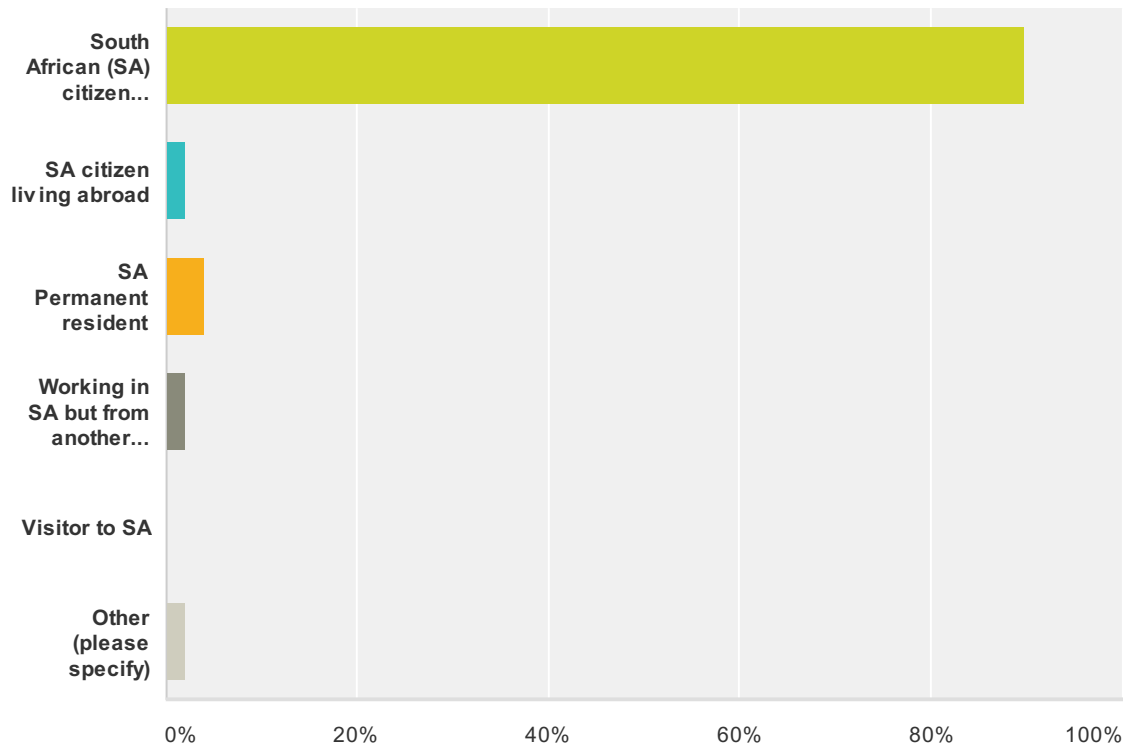

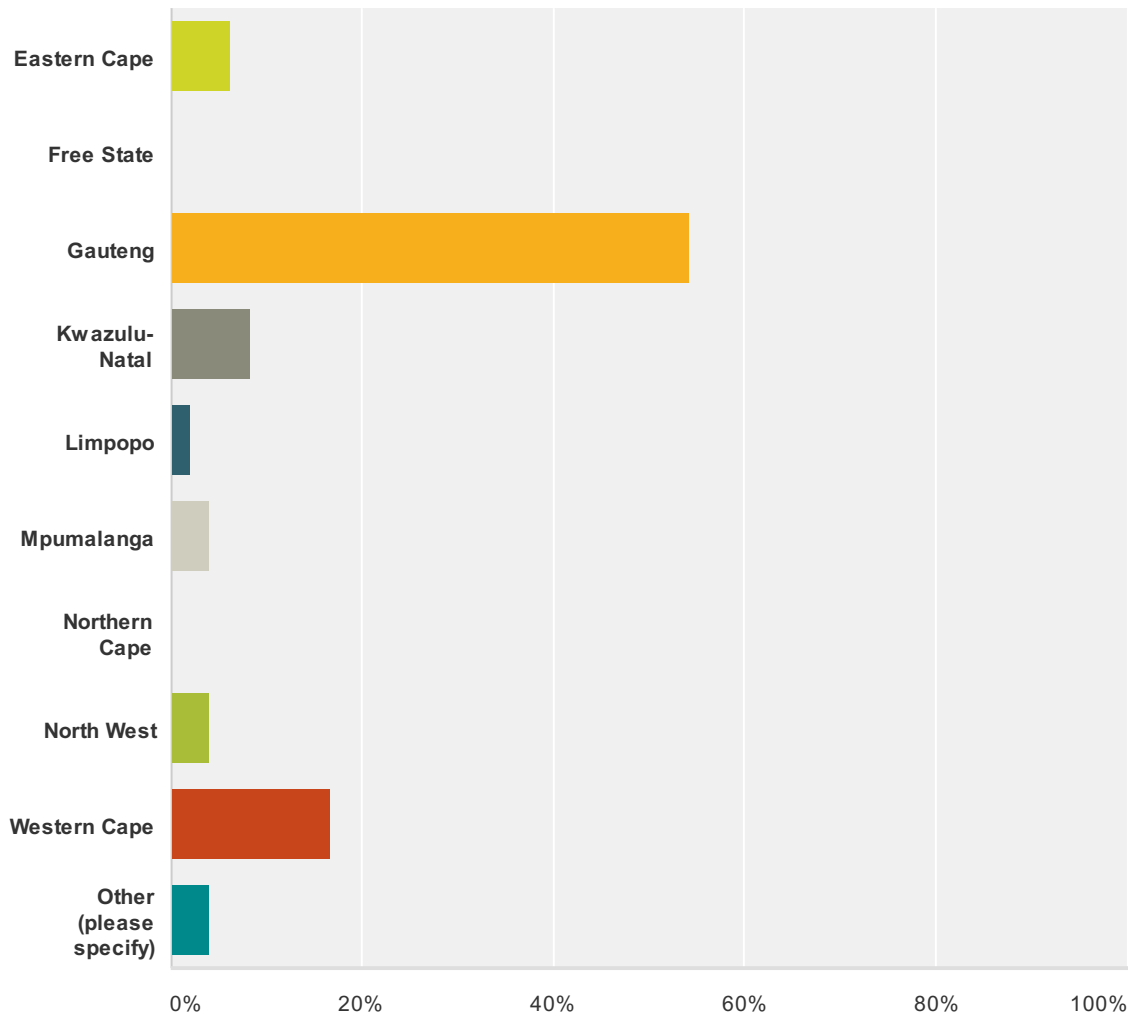

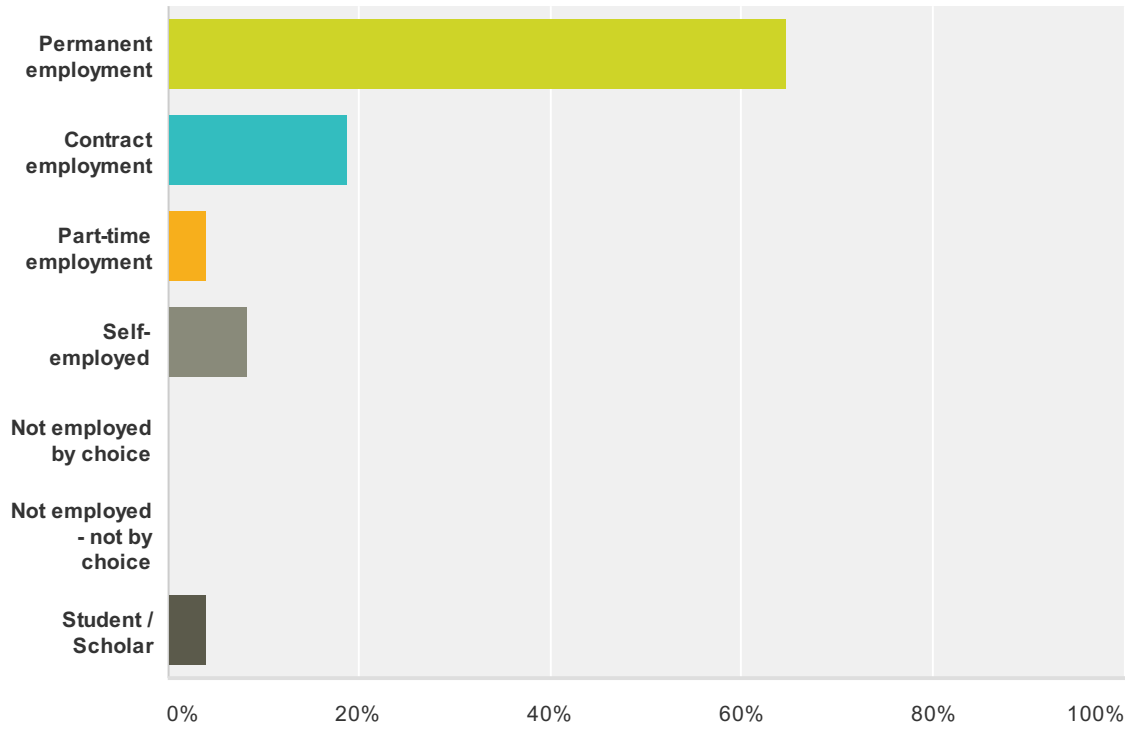

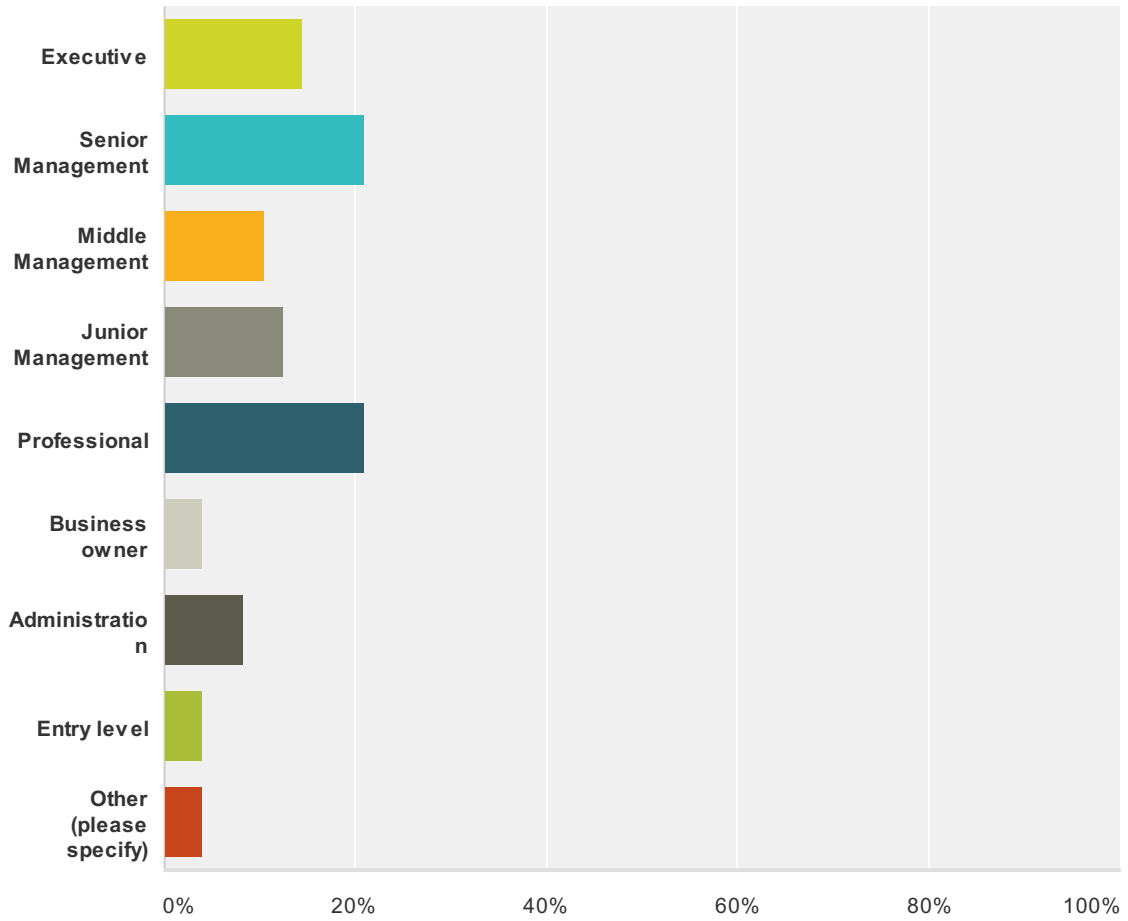

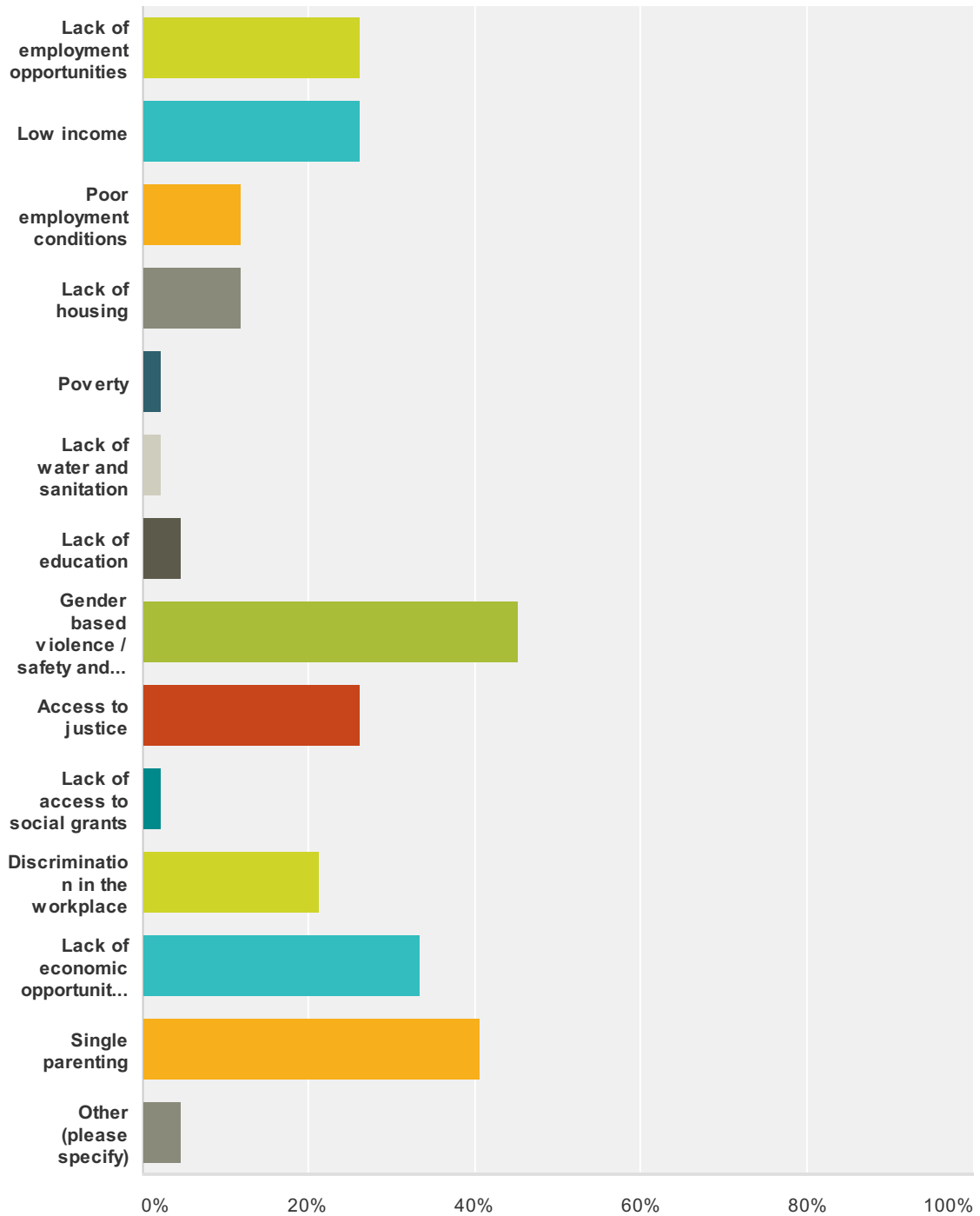

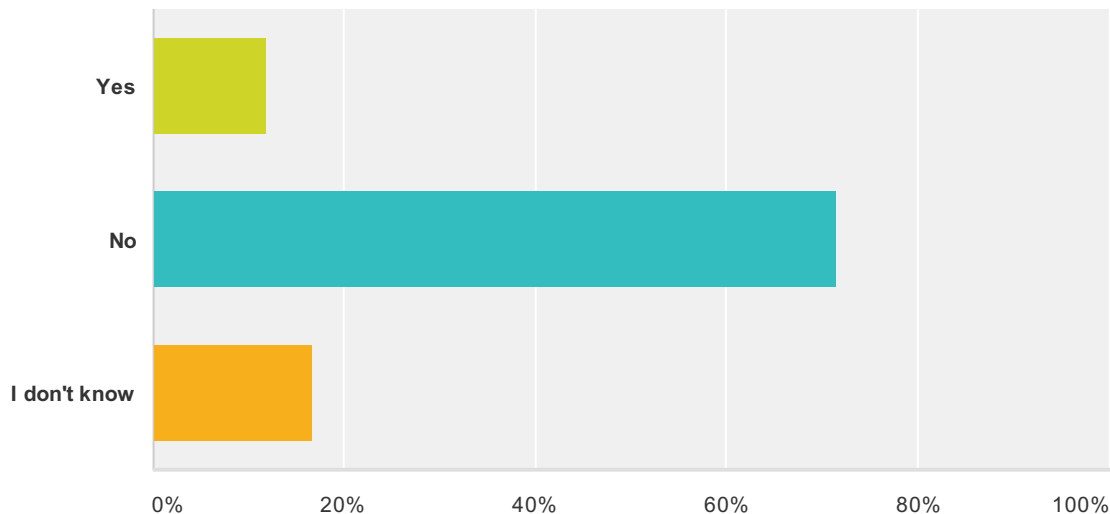

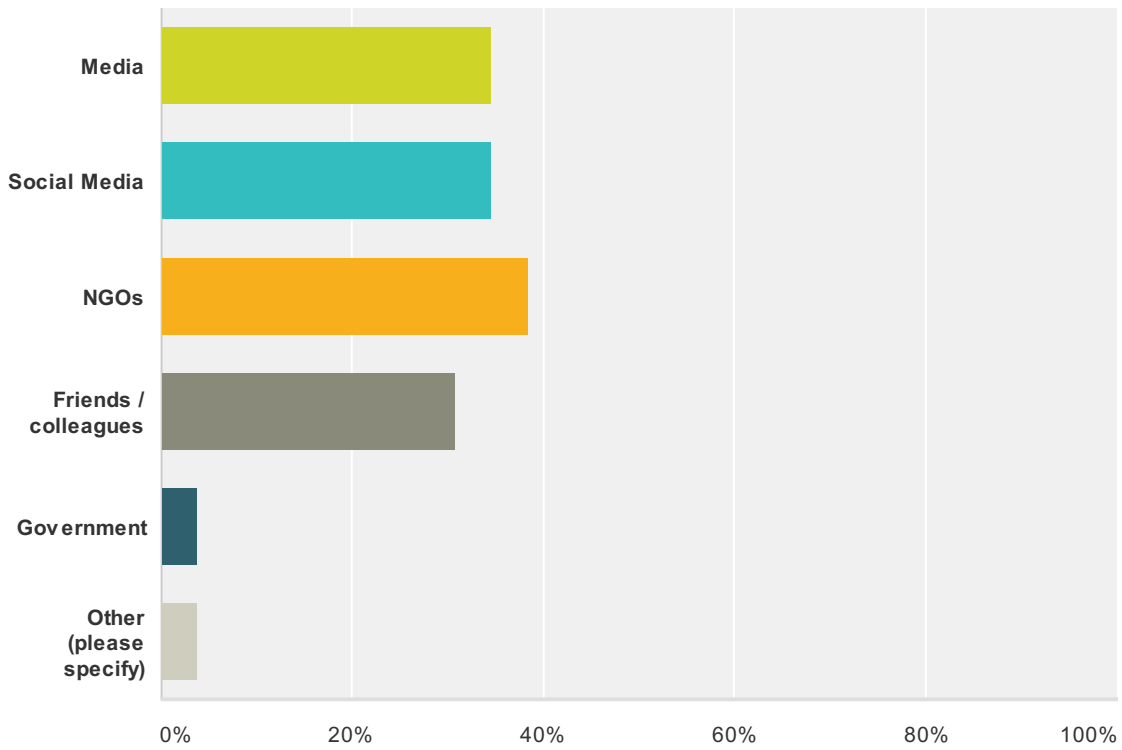

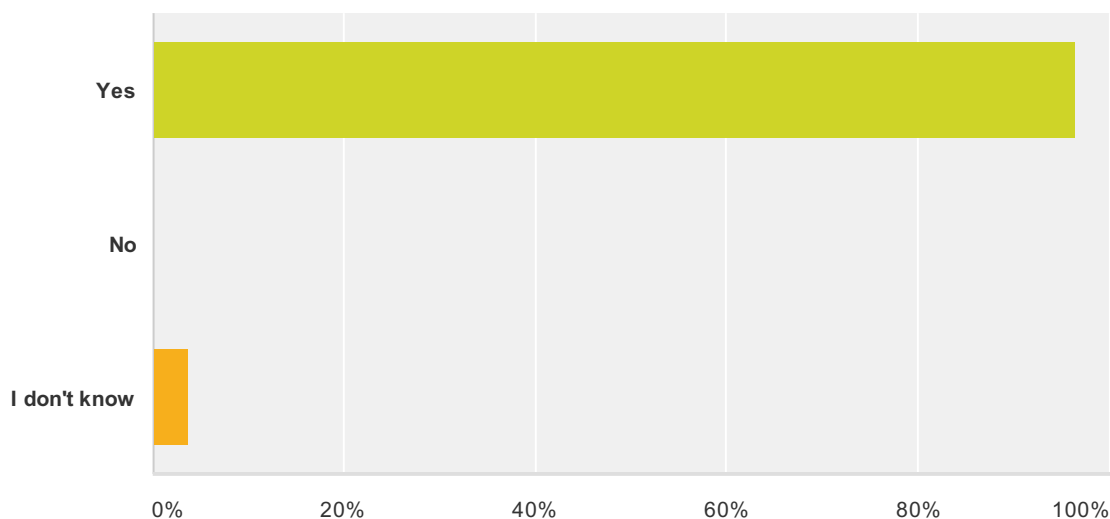
