It appears there were other tender notices advertised between the 26<sup>th</sup> of March and the 16<sup>th</sup> of April but a notice suspending all tenders advertised during this lockdown period was posted. There is no record on the website of any tender notices from that period onwards. Nevertheless, in a separate folder for closed tenders, there are a number of tender notices from the period before the lockdown. These date back to 2016.
