

i. *Yintoni uMnqophiso waMazwe ngaMazwe waMalungelo eZoqoqosho, eZentlalo kune neNkcubeko?*


UMnqophiso waMazwe ngaMazwe waMalungelo eZoqoqosho, eZentlalo kune neNkcubeko (uMnqophiso) sisivumelwano samalungelo abantu samazwe ngamazwe sombutho waMazwe aManyeneyo (i-UN). Samkelwa ngomhla we-10 kuDisemba 1966 saza saqalisa ukusebenza ngomhla wesi-3 kujanyuwari 1976. Lo Mnqophiso ukhusela intlaninge yamalungelo ezoqoqosho, ezentlalo nenkcubeko (amalungelo ezentlalo nawoqoqosho). Uhlengene noMnqophiso waMazwe ngaMazwe waMalungelo eZoluntu neZopolitiko (International Covenant on Civil and Political Rights - ICCPR), nowamkelwa ngaxeshanye, lo Mnqophiso usisiseko somthetho wamalungelo abantu wamazwe ngamazwe kwaye watyikitywa ngamazwe ali-169 ehlabathini liphela. Onke amazwe ase-Afika, ngaphandle kweBotswana, iMozambique neSouth Sudan, atykitya kwaye ke ngoko abophelelekile kulo Mnqophiso. UMzantsi Afrika wawutyikitya lo Mnqophiso ngomhla we-12 kujanyuwari 2015.

UMgaqo oNganyanzelekanga walo Mnqophiso (uMgaqo oNganyanzelekanga) wamkelwa ngomhla we-10 kuDisemba 2008 yi-UN waza waqalisa ukusebenza ngomhla we-5 kuMeyi 2013. Amazwe angamashumi amabini anesine atykitya lo Mgaqo uNganyanzelekanga, amane kuwo ngawase-Afrika. UMgaqo oNganyanzelekanga uvumela abantu ukuba bangenise izikhala kumgangatho wamazwe ngamazwe xa bengakwazi ukufikelela kubulungisa kwiiinkundla zamazwe abo ngokunyashwa kwamalungelo ezentlalo noqoqosho. Ukanti, ilizwe labo kumele litiyikity uMgaqo oNganyanzelekanga kuqala. UMzantsi Afrika awukawutiyiti uMgaqo oNganyanzelekanga.

UMnqophiso uphawula ukuba abantu abaninzi abalufumanu olunye ioninzi lwamalungelo asisiseko kwaye usabela kwinyaniso yokuba abantu abaninzi baphila ubomi bentsokolo, bayalamba, abanandawo zokuhlala zifanelekileyo kwaye abakwazi ukufikelela kwimfundu.

Amalungelo akulo Mnqophiso aquka:

- Ilungelo lokusebenza nelokuba umntu wonke akwazi ukuzisebenzela ngokukhululekileyo kumsebenzi awukhethayo (iNqaku 6);
- Ilungelo leemeko zomsebenzi ezinobulungisa neziluncedo (iNqaku 7);
- Ilungelo lokuseka iiyuniyonu kune nokujoyina iyuniyonu umntu ayikhethayo (iNqaku 8);
- Ilungelo lokhuseleko Iwezentlalo, kuquka ne-inshorensi yezentlalo (iNqaku 9);
- Ilungelo lokukhuselwa kosapho (iNqaku 10);
- Ilungelo lomgangatho wokuphila ofanelekileyo, kuquka ukutya okwaneleyo, iimpahla kune nezindlu, kune nokuphuculwa okuqhubekekayo kweemeko zokuphila (iNqaku 11);
- Ilungelo lokonwabela owona mgangatho uphezulu unokubakho wempilo ngokomzimba nangokwasengqondweni (iNqaku 12);
- Ilungelo lemfundu, kuquka imfundu enyanzelekileyo yamabanga asisiseko (iNqaku 13); kune Namalungelo okuthatha inxaxheba kubomi benkcubeko, ukonwabela iinzudo zenkqubela yezenzululwazi kune nokusetyenziswa kwayo, kune nenzudo yokukhuselwa kwezabelo zezithethe nezemali ezizipphumo zeemveliso zenzululwazi, zoluncwadi okanye zobugcisa (iNqaku 15).



ii. Yintoni iKomiti yaMalungelo eZoqoqosho, eZentlalo kune neNkcubeko?

IKomiti liqumrhu leengcali ezizimeleyo ezibeka esweni ukusetyenziswa koMnqophiso ngamazwe. Onke amazwe anoxanduva lokungenisa rhoqo iingxelo ezingena rhoqo kwiKomiti malunga nendlela la malungelo asetyenziswa ngayo kumazwe awo. Amazwe kumele achaze kuqala kwiminyaka emibini yokwamkelwa koMnqophiso aze emva koko achaze rhoqo kwiminyaka emihlanu. IKomiti ihlolila ingxelo nganye ize iqubisane neenkxalabo kune neengcebiso eziya kwelo lizwe ngendlela yokuqulunqwa 'kokuFunyanisiweyo kwaGqitywa Ngako'.

iii. Indlala yokwensiwa kweengxelo zoMnqophiso

UMzantsi Afrika ungenise ingxelo yaho yokuqala kwiKomiti ngomhla wama-25 ku-Apreli 2017. Ngo-Okthobha 2018, iKomiti ihlolila uMzantsi Afrika ukuze ibone indlala urhulumente waseMzantsi Afrika aluzalisekisa kakuhle ngayo uxanduva Iwakhe phantsi kwalo Mnqophiso. IKomiti yenze iqela lokuFunyanisiweyo kwaGqitywa Ngako elidandalazisa indlala uMzantsi Afrika onokuphucula ngayo irekhodi lawo ekuzalisekiseni amalungelo ezokuhlala noqoqosho. Urhulumente waseMzantsi Afrika kufuneka ngokwemimiselo yezbophelelo zakhe zoMnqophiso enze ingxelo yenqubela yakhe malunga nokwensiwa kwezi ngcebiso zichaziweyo ngo-Okthobha 2020 aze anikezele enye ingxelo epheleleyo kwiKomiti ngomhla wama-31 ku-Okthobha 2023.

Ukukhutshwa kokuFunyanisiweyo kwaGqitywa Ngako ngowona msebenzi ubalulekileyo wamaqumrhu ezivumelwano zamalungelo abantu. Kubonelela gethuba lokuba i-UN ibonelele ngamaggabantsintshi emeko yamalungelo abantu kwelo lizwe kune nengcebiso ngemiba efuna ukuphuculwa. Olu xwebhu sisishwankathelo sokuFunyanisiweyo kwaGqitywa Ngako kwaseMzantsi Afrika.

1. Ukusetyenziswa ngokupheleleyo koMnqophiso emthethweni nakumgaqonkqubo

IKomiti iyavuma ukuba uMqaqosiseko waseMzantsi Afrika unenkubela kwimiba yamalungelo ezentlalo noqoqosho, kwaye ifuthe lawo liye lomelezwa nangakumbi ngendlela iKundla yoMqaqosiseko etolika ngayo amagatyawo. Ukanti iKomiti iphawule ukuba uMqaqosiseko awuquki onke amalungelo oMnqophiso, afana nelungelo lokusebenza kune nelungelo lomgangatho wokuphila ofanelekileyo. IKomiti icebise ukuba urhulumente kumele aqinisekise ukuba onke amalungelo oMnqophiso aqukiwe kuMqaqosiseko waseMzantsi Afrika. Enye ingcebiso ephambili kukuba urhulumente amkele ilungelo lemfundu esisiseko esimahala (amanqaku 13 (2) (a) no-14 oMnqophiso)¹, kananjalo avumele nokuba uMnqophiso usetyenziswe kwiinkundla zasekhaya.

2. Ukuqokelelwa kwemali engonelanga kwiKhomishoni yaMalungelo aBantu yaseMzantsi Afrika

IKomiti icebise ukuba urhulumente abeke imali eyaneleyo yokuhlawulela iKhomishoni yaMalungelo aBantu yaseMzantsi Afrika ukuze ikwazi ukwenza umsebenzi wayo ngokufanelekileyo.

3. Ukuqokelelwa kweengombolo ngamalungelo ezentlalo noqoqosho

IKomiti icebise ukuba uMzantsi Afrika uphucule inkubo yokuqokelelwa kweengombolo ukuze kuge nokuqokelelwa iingombolo ezipheleleyo nezithembekileyo. Ezo ngombolo kumele zicwangcisiwe ngohlanga, ngesini nangephondo ukuze kuge nokuhlolwa komgangatho wokonwabela amalungelo akhankanyiweyo kuMnqophiso, ingakumbi kubantu nakumaqela ahlelekileyo.

4. Ukhuselo Iwabakhuseli bamalungelo abantu

Le Komiti iphawule izisongelo abagxalathelene nazo abakhuseli bamalungelo abantu, ingakumbi abo basebenzela ukukhuthaza nokulwela amalungelo oMnqophiso kumashishini ezimbiha nawezemimandla esinqongileyo. Malunga noko iKomiti icebise ukuba urhulumente abonelele ngendawo ekhuselekileyo yomsebenzi wabakhuseli bamalungelo abantu wokukhuthaza nokukhusela amalungelo ezentlalo noqoqosho. Oku kubandakanya:

- i. Ukuqinisekisa ukuba yonke imiba exeliwego yokoyikisa, yokugrogrisa neyobundlobongela obenziwa kubakhuseli bamalungelo abantu iphononongwa ngokukhawuleza nangocoselelo kwaye abenzi bobubi bafakwa umthetho;
- ii. Ukuqinisekisa ukuba abasebenzi bonyanzeliso lomthetho baqeleshwe ngokufanelekileyo ukuze kuthintelwe ukugxagxanyiswa kakhulu kwabaqhankqalazi
- iii. Ukuhlaziya umthetho omayelana nolawulo loqhankqalazo ngenjongo yokuwuthintela ungasetyenizwsa kakubi ukucinezela uqhankqalazo oluzolileyo.

5. Uukukhuthaza nokukhusela amalungelo abantu bemveli

Ukwamkelwa koMthetho weeNkokheli zeMveli nezamaKhoi-San kwabhengezwa njengenyathelo elilungileyo ukuqinisekisa ukuba abantu bemveli baseMzantsi Afrika nabo bawonwabela ngokupheleleyo la malungelo akhuselwe kulo Mnqophiso.


Le Komiti icebise urhulumente ukuba:

- i. Asayine i-International Labour Organization Indigenous and Tribal Peoples Convention No.169 of 1989;
- ii. Aqinisekisa ukuba abantu bemveli bonwabela ngokupheleleyo amalungelo akhuselwe kulo Mnqophiso; kwaye
- iii. Athethathethane, kwaye anike abantu bemveli ithuba lokuthatha inxaxheba ekusetyenzisweni koMthetho weeNkokheli zeMveli nezamaKhoi-San.

6. Urhulumente kumele aqubisane nokuphathwa ngokungalinganiyo kwabantu

Amaqondo aphakame ngokungaginyekijo empatho engalinganiyo ngokwasezimalini nakwezentlalo kubalulwe, kwaye ngokokubona kwale Komiti, kubonisa ukuba lo mfuziseloo wophuhliso loqoqosho uzungulwa ngurhulumente awuquki wonke umntu ngokwaneleyo. Le Komiti iphawule ukuba:

- i. Kukho impatho engalinganiyo kakhulu kweli lizwe, phakathi kwamaphondo naphakathi koomasipala basemaphandleni nabasezidolphini.
- ii. Imigaqonkqubo yezemali kunye nemithetho yerhafu yeli lizwe ayilivumeli liqokelele oovimba aboneleyo abafunekayo ukuze kuthotywe ukuphathwa kwabantu ngokungalinganiyo.
- iii. Akukho hlolo lwefuthe Iwamalungelo abantu Iwensiweyo, ingakumbi kumakhaya anemivuzo emincinci ngaphambi kokunyuwsa kwerhafu i-value added tax (iVAT); kwaye
- iv. Ukuhxaphaka kokuhamba kwezemali ngendlela engekho mthethweni kunye nokuphetshwa kwerhafu kuneftuheliebli kakhulu kumandla okuqokelela oovimba bezemali aboneleyo bokujalisa izibophelelo zamalungelo ezentlalo noqoqosho.



Le Komiti yenze iqela leengcebiso, eziphambili kuzukuka urhulumente kumele:

- v. Ahlole umgaqonkubo wakhe werhafu nowenkitho ukuze kubekho ingeniso eyaneleyo yokuzalisekisa imisebenzi yakhe;
- vi. Athobe ukungalingani kwemimandla ekonwabeleni amalungelo phantsi kwalo Mnqophiso;
- vii. Ahlole ifuthe lokunyuswa kweVAT, ingakumbi kumakhaya anemivuzo emincinci, aze athathemanyathelo okulungisa oku njengoko kuyimfueko;
- viii. Andise iinzame zokuphelisa ukuhamba kwezemali ngokungekho mthethweni nokuphetshwa kwerhafu; aze
- ix. Aphinde ahlole umfuziselo wakhe wokukhulisa uqoqoshu ukuze ajongise imibombo kwiindlela zophuhliso eziquka wonke umntu.

7. Ukuqaliswa kwamanyathelo okuthoba inkcitho

IKomiti ibinexhala lokuba urhulumente ungenisa amanyathelo okuthoba inkcitho aphelele ngokuthotywa kakhulu kolwabiwomali Iwezempilo, imfundu kunye namanye amacandelo eenkonzo zoluntu, kwaye oku kusenokwenza ukupathatha ngokungalinganiyo kwabantu kubemandundu nangakumbi kwindlela abonwabela ngayo amalungelo aphantsi kwalo Mnqophiso.

Ngokwale Komiti, apho amanyathelo okuthoba inkcitho engenakuphetshwa, kumele abe ngawexeshana, ajonge kuphela eli xesha lonxunguphalo, abe ayimfuneko kwaye alinganiselwe, kwaye kufanele angapheleli ngocalucalulo nolwandiso lokupathatha kwabantu ngokungalinganiyo.

Le Komiti icebise ukuba urhulumente anyuse inqanaba lokunikezelwa kwemali kwiinkalo zokhuseleko Iwezentlalo, Iwezempilo nemfundu.

8. Abantu abane-albinism

Umzabalazo wabantu abane-albinism buyixhalabisa ngokukodwa le Komiti, yakube ibone ubunggina bokuba abantu abane-albinism bayaqhubeka nokuhlaselwa kwaye bagxalathelene noccalucalulo ekonwabeleni amalungelo aphantsi kwalo Mnqophiso, kuquka ilungelo lokusebenza kunye nelungelo lemfundu. IKomiti icebise ukuba urhulumente enze iinzame ezongezelelekileyo ukuphelisa ucalucalulo nobundlobongela obenwi kubantu abane-albinism ngokuthi:

- i. Omeleze imithetho;
- ii. Akhuthaze ukwaziswa koluntu kunye nothethathethwano neenkokheli nabanyangi bemveli ngendlela eyondelelanisiweyo nehlanganisiweyo; kwaye
- iii. Aququzelele ukufikelela kwabantu abane-albinism emsebenzini nakwimfundu ngokubabonelela ngenkxaso nangoncedo olufanelekileyo.

9. Avumele abacela indawo yokuzimela bafikelele kwiinkonzo zezentlalo

I Komiti ivumile ukuba eli lizwe lisindleka iimbacu ezininzi kunge nabacela iindawo yokuzimela abaninzi nabaye banyanjeleka ukuba baqhwashe kumazwe abo. Nangona iphawule inkqubela enku eye yenziba ekusebeni icicelo zendawo yokuzimela, le Komiti ibinexhala lokuba semva kwezelcelo zendawo yokuzimela ezilindele inkqubo yesibheno kunge nesiphakamiso sokumisela amaziko okusebenza icicelo zendawo yokuzimela kwimandla esemdeni. Ukuqualisa isicwangciso esinjalo kusenokunyina ukufikelela kwabaceli bendawo yokuzimela kuncedo lwezomthetho, unakekelo lwempilo, imfundo nezibonelelo zoncedo lwezentlalo.

Le Komiti icebise urhulumente ukuba:

- i. Akhawulezise ukuleqa ezi icelcelo zendawo yokuzimela zilindileyo kwinkqubo yesibheno;
- ii. Aqinisekise ukuba abaceli bendawo yokuzimela baqinisekiswe ukufikelela kakuhle kuncedo lwezomthetho, unakekelo lwempilo olusisiseko kunge nemfundu kwaye baxhaswe ekwenzeni icicelo sezbonelelo zoncedo lwezentlalo; kwaye
- iii. Aqinisekise ukuba abacela indawo yokuzimela bangazixhasa kwaye bonwabele ilungelo lokusebenza.

10. Athobe amaqondo okungabikho kwengqesho

Ukungabikho kwengqesho kuphakame kakhulu kwele lizwe, kwaye kumi kwiipesenti eziyi-27.5 eluntwini jikelele nakwipesenti ezingama-39 kulutsha. Nangona iqaphelle uludwe lweenqubo eseze zikho zokunceda abakhangelia umsebenzi bafumane ingqesho, le Komiti ibonise inkxalabo ngemilinganiselo yokungabikho kwengqesho, kuquka nokunganeli kwenani eliyi-2 pesenti elimiselwe ingqesho yabakhubazekileyo kumashishini abucala.

Le Komiti icebise urhulumente ukuba:

- i. Enze zonke iinzame ukuthoba amaqondo aphakamileyo okungabikho kwengqesho, kuquka nokuphucula amathuba oqequeso lwezakhono kunge nekharityulam efundiswayo, kananjalo nangokuphulisa iinkqubo, ingakumbi ezbantu abatsha, ukuze bahlangabezane neemfuno zemarice yengqesho nangokubonelela abaqeshi negezinto zokubakhuthaza ukuba baqeshe abantu abatsha; kwaye
- ii. Aqalise kakuhle ingqesho yezi pesenti zi-2 zabantu abakhubazekileyo, ingakumbi kumashishini abucala, kwaye aqinisekise ukuba iimfuno zasemsebenzini zaba basebenzi ziyabonelelwaa.

10.1 Ukungaphumeleli kwengqesho kumashishini asesikweni kunge nakuqoqosho olungekho sesikweni

Umba oxhalabiso nangakumbi kule Komiti linani elikhulu labasebenzi abasebenza kuqoqosho olungekho sesikweni ngaphandle kwamalungelo engqesho nokhuseleko olwaneleyo lwezentlalo. Ngoku akukho mithetho ilawula uqoqosho olungekho sesikweni, nto leyo ebeka abasebenzi abanjalo emngcipheweni wokuxhatshazwa ngabaqeshi nangamagosa onyanzeliso lomthetho. Omnye umba oxhalabisayo yinto le Komiti ebhekise kuyo "njengokwanda kokwenziwa kwengqesho yezingxungxu kuqoqosho olusesikweni." Xa kujongwa ezi zinto zixhalabisayo, le Komiti icebise urhulumente ukuba:

- i. Angenise imithetho yokulawula uqoqosho olungekho sesikweni, ngenjongo yokukhusela abasebenzi bangaxhatshazwa, kuquka namagosa okunyanzelisa umthetho;
- ii. Andise iinkalo ezipantsi kolawulo lwemithetho yezengqesho kunge nokhuseleko lwezentlalo lwaba basebenzi;

- iii. Aququzelele ukutshintshela kwabasebenzi abakuqoqosho olungekho sesikweni ukuya kuqoqosho olusesikweni; kwaye
- iv. Athintele aze alungiselele ukwenziwa kwengqesho yezingxungxu kuqoqosho olusesikweni.

11. Ukhuseleko Iwamalungelo abasebenzi bezesondo

Le Komiti ibinexhala lokuba abasebenzi bezesondo, noninzi lwabo olungamabhinga, abawonwabeli amalungelo aqulathwe kulo Mnophiso, ingakumbi ilungelo lokusebenza, ilungelo lezempilo nelungelo leeyuniyon. Le Komiti kananjalo ibonise inkxalabo yokuba abasebenzi bezesondo bahlala begrogriswa kwaye bebanjwa bavalelwe ngaphandle kwsizathu, kananjalo bayanyanzelwa ukuba babelane ngesondo simahla kwaye banyobe amapolisa ngenxa yokwenziwa kokuthengisa ngesondo kube lulwaphulomthetho. Ukwenziwa kokuthengisa ngesondo kube lulwaphulomthetho kwenza kube nzima ukuxela ubundlobongela ngokwasemzimbeni nangokwesondo okwenziwa kubasebenzi bezesondo.

Le Komiti icebise urhulumente ukuba:

- i. Amisele unqumamiso Iwangoko nangoko lokubanjwa kwabasebenzi bezesondo de kumiselwe isimo sezomthetho sabasebenzi bezesondo;
- ii. Aqwalasele ukuyekisa ukuthatha ukuthengiswa kwsondo njengolwaphulomthetho;
- iii. Akhusele abasebenzi bezesondo ekugrogrisweni ngamapolisa, kananjalo nakubundlobongela ngokwesondo nangokwasemzimbeni kunya nokuxhatshazwa ngabo bathengisa ngabantu, ngabanini beendawo ezithengisa ngesondo kunya nabanye;
- iv. Abonelele ngenkxaso kunya noncedo kumaxhoba okugrogrisa, obundlobongela kunya nokuxhaphaza; kwaye
- v. Athathe amanyathelo okuthoba ukufunwa kokuthengisa ngomzimba aze abonelele abasebenzi bezesondo ngamanye amathuba okuphila.

12. Amalungelo engqesho abasebenzi basekhaya nabasezfama

- i. Abasebenzi basekhaya nabasefama badla ngokusebenza phantsi kweemeko ezibakhaphazisayo;
- ii. Abasebenzi basekhaya abakhuselwanga ngokonzakala nokubhubha kwasemsebenzini phantsi kweCompensation for Occupational Injuries and Diseases Act;
- iii. Nangona le ndawo yokuhlala bayinikwayo iyinxalenye engundoqo yomvuzo wabo, umgangatho wale ndawo yokuhlala awulawulwa; kwaye
- iv. Umthetho awuboneleli nto ngohlolo Iwengqesho olungaziswayo olwenziwa emakhayeni nangeendlela ezisebenzayo ezivumela abasebenzi basekhaya benze izikhalaizo ezisesikweni malunga neemeko zabo zengqesho.

Kuye kwensiwa iqela leengcebiso yile Komiti, neziquka:


- v. Ukuba urhulumente kumele enze iinzame zokukhusela abasebenzi basekhaya nabasefama bangaxhatshazwa kwaye ababonelele ngokhuselo oluphuculiwego lwezengqesho nezentlalo;
- vi. Ukomelezwa komthetho ukhusele nabasebenzi basekhaya kukonzakala nokubhubha kwasemsebenzini, kuze kubonelelw ngeengcebiso zeomthetho ngomgangatho wendawo yokuhlala;
- vii. Kuhlale kuqhutuya uhlolo lwezengqesho olungamazisyo umqeshi kumakhaya aqeshileyo;
- viii. Ukuqinisekisa ukuba abasebenzi basekhaya nabasefama bayafikelela kwiindlela zokufaka izikhala zo ezesebenzay; kune
- ix. Nokwandisa ulwazi loluntu lwamalungelo abasebenzi basekhaya.

13. Iimeko zokusebenza nezokuhlala kwishishini lezimbiwa

Indawo eye yasesweni mayelana neemezo zomsebenzi zabasebenzi bezimbiwa kune nokungabikho kohlo lwezengqesho kumashishini ezimbiwa, nokuye kwakhokelela kumaqondo aphakamileyo okonzakala nezifo zasemsebenzini. Eyona nto ixhalabisayo kananjalo kukuba uninzi lwabasebenzi basemgodini luhlala ematyotyombeni apha ngasemigodini ngaphandle kwamanzi, kweethoyilethi okanye kombane, kwaye izicwangciso zezentlalo nezengqesho ziye zingenziwa ngabaqeshi. Abasebenzi basemgodini abangamabhinga baye bafumane ucalucalculo nokufumana ubundlobongela ngokwezesondo.

Le Komiti yenye iingcebiso kurhulumente ukuba aphucle iimeko zomsebenzi nezokuhlala zabasebenzi basemgodini ngokuthi:

- i. Aqinisekise ukunyanzelisa kweMine Health and Safety Act kune ne-Occupational Health and Safety Act kumashishini ezimbiwa;
- ii. Omeleze uhlolo lwezengqesho kwishishini lezimbiwa;
- iii. Kuqinisekiswe ukuba abasebenzi basemgodini abonzakeleyo kune nabasebenzi basemgodini abanefizo zasemsebenzini bayafikelela kunakekelo olululo kwaye bayakwazi ukuthatha amanyathelo ezomthetho ukwenza abaqueshi baphendule;
- iv. Ukuquhuba uhlolo rhoqo lwemingcipheko yeengozi zokhuseleko nempilo yabasebenzi basemgodini, ingakumbi abasebenzi abazingxungxu nabekontraka;
- v. Ukukhuthaza ukhuseleko nesidima sabasebenzi basemgodini abangamabhinga, ukuquhubisana nokuphathwa ngokungalinganiyo kune nobundlobongela obusekelwe kwisini, nokuphelisa izithetho zasemsebenzini ezigqugqiswa ngamatdoda kweli shishini;
- vi. Ukuphucula iimeko zokuphila zoluntu lwabasebenzi basemgodini, nokuqinisekisa ukufikelela kwabasebenzi basemgodini kwiinkonzo eizifanelekileyo zeindlu, amanzi, umbane, ithoyilethi, unakekelo lwempilo, imfundu kune nezinye iinkonzo zezentlalo; kune
- vii. Nokunyanzelisa ngokungongqo izibophelelo ezymayelana nezentlalo kune nezicwangciso zengqesho kune nokumisela izohlwayo zabaqeshi kumatyalwa okungathotyelwa komthetho kuquka nokuxuthwa kweelaisensi.



14. Owona mvuzo umcinane mawuqinisekise umgangatho wokuphila ofanelekileyo

Ngokuphathelelene nowona mvuzo mncinane, iKomiti ibonise inkhalabo yayo yokuba:

- i. Lo mlinganiselo wangoku wowona mvuzo mncinci ngeyure (ongangama-20 eerandi) awuqinisekisi ukuba abasebenzi kanye neentsapho zabo baphila ngokusemgangatheni ofanelekileyo;
- ii. Eyona mivuzo mincinci yabasebenzi basekhaya neyabasebenzi basefama iye yamiselwa kumlinganiselo ongaphantsi nangakumbi kunalo okwango; kwaye
- iii. Nabasebenzi abaninzi abakhuselwanga ngumthetho wowona mvuzo umcinane.

lingcebiso eziphambili zeKomiti kurhulumente kukuba:

- i. Asebenzise umlinganiselo omnye wowona mvuzo mncinane kuwo onke amashishini, kuukha ekhaya, efama, nasezivenkileni; kwaye
- ii. Anyuse umlinganiselo wowona mvuzo mncinci kuzwelone aze emana ewulungisa rhoqo ngokweendleko zokuphila ukuze aqinisekise umgangatho wokuphila ofanelekileyo wabasebenzi kanye neentsapho zabo.


15. Avale isikhewu phakathi kwemivuzo yezini kwaye aqinisekise ukuhlawulwa ngokulinganayo ngokwenza umsebenzi onexabiso elinye

Isikhewu phakathi kwemivuzo yezini, esimi ku-27 pesenti, kananjalo nepesenti ephakamileyo yamabhinqa akwimisabenzi ephela msinyane, inefuthe ekonwabeleni kwamabhinqa amalungelo phantsi koMnqophiso ubomi bawo bonke. Into exhalabisayo kukuba imithetho yezengqesho kanye nezivumelwano zoninzi azihlanganis inkolelo yokuhlawulwa ngokulinganayo ngomsebenzi wexabiso elinye.

Le Komiti icebise urhulumente ukuba azame nangakumbi ukuvala esi sikhewu seentlawulo phakathi kwamadoda namabhinqa kwaye aqinisekise ukuba inkolelo yokuhlawula ngokulinganayo ngomsebenzi wexabiso elinye iyaqukwa kwimithetho yezengqesho nakwizivumelwano zoninzi kwaye isetyenziswa ngokufanelekileyo.

16. Imali eyaneleyo yohlolol Iwezengqesho

Le Komiti icebise urhulumente ukuba anyuse umlinganiselo wemali enikezelwe kwiSebe loHlolol neeNkonzo zoNyaneliso kwaye aqinisekise ukuba kukho igela eliqeqeshiweyo labahloli bezengqesho ukuze kuthotywe ukuphakama kwenani labayekayo. Le Komiti ikwacele urhulumente ukuba aqinisekise ukuba imiyalelo yokuthotyelwa komthetho evela kubahloli bezengqesho iyenziwa.







17. Ukhuselo Iwamalungelo eeyuniyoni

Eyona nto ixhalabisayo kwiKomiti kukuba abasebenzi basekhaya, abasebenzi basefama kune nabasebenzi bemisebenzi yexeshana baye babekelwe ecaleni kwinkqubo yoithethathethwano ioninzi. Kwakujongwa le nkxalabo ingentla, iKomiti icebisa urhulumente aqinisekise ukuba:

- i. Bonke abasebenzi, kuquka nabo bakwimisebenzi yexeshana, bathatha inxaxheba kwinkqubo yokwenza izigiqibo ezimayelana neemeko zabo zomsebenzi njengoko kubonelelw kuMgaqosiseko nkwimithetho yezengqesho; kwaye
- ii. Izlungiso zeLabour Relations Act kumele zibonelele ngokhuselo Iwamalungelo ezenggesho olomeleleyo nangakumbi, kuquka nelungelo logwayimbo.

18. Ukhuseleko Iwezentlalo

Nangona le Komiti ivuma ukuba inkamnkam ibisisixhobo esibalulekileyo ekuthobeni intlupheko kweli lizwe, le Komiti isenexhala lokuba ireshiy omentupheko kweli lizwe iphakame ngendlela engamkelekanga. IKomiti ibalule la manqaku abalulekileyo alandelayo:

- i. Imilinganiselo yezibonelelo zoncedo Iwezentlalo lukarhulumente iphantsi kakhulu ukuba ingaqinisekisa umgangatho wokuphila ofanelekileyo wabo bazifumanayo kune neentsapho zabo;
- ii. Abo bangenamivuzo okanye banemivuzo emincinci abaphakathi kweminyaka eli-18 nengama-59 nabakwaziyo ukusebenza abakhuselwanga ngamalungiselelo akhoyo;
- iii. Amanani akhuselwe ngezibonelelo ze-Unemployment Insurance Fund asephantsi kwaye abekela ecaleni abasebenzi abakuqoqoshu olungekho sesikweni, abasebenzi bamaxesha athile enyakeni kune nabasebenzi abazisebenzelayo; kwaye
- iv. Neengombolo nee-akhawunti zebhanki zabo bafumana inkamnkam ziye zasetyeniswa kakubi kwaza kwabhalwa phantsi into eninzi yeemali ezitsalwa ngokungagunyaziswanga kwizibonelelo zezentlalo.

Le Komiti yenze iqela leengcebiso, neziquka ummiselo wokuba urhulumente:

- i. Anyuse imilinganiselo yezibonelelo zoncedo Iwezentlalo lukarhulumente ziye kumlinganiselo oqinisekisa umgangatho wokuphila ofanelekileyo wabo bazifumanayo kune neentsapho zabo;
- ii. Aqinisekise ukuba abo baphakathi kweminyaka eli-18 nengama-59 abanemivuzo emincinci okanye abangenamivuzo bayafikelela kuncedo Iwezentlalo;
- iii. Andise abakhuselwaga ngezibonelelo ze-Unemployment Insurance Fund ibe ngabo bonke abasebenzi, nokuba isikhundla sabo sithini na;
- iv. Aqwälasele ukubakho kwethuba lokuba angenise inkamnkam esisiseko kawonkewonke; kwaye
- v. Aquabisane nemeko edalwe yinkqubo yokuqeshwa kwenkampani yangaphandle ukuhlawula inkamnkam aze aqinisekise ukuba zonke iintlawulo zenziwa ngexesha ngeli xesha lokutshintshela kwenye inkqubo.



19. Ukuphuculwa okufunekayo kubhaliso Iwabantwana abazelweyo

Ipesenti ezilishumi zabantwana baseMzantsi Afrika azikabhaliswa kwaye ukubhaliswa kwabantwana abazelweyo kuyathintelwa, ingakumbi kwabo banomzali omnye okanye bobabini abavela kumazwe angaphandle kunye nabo banootata ababodwa, ngenxa yemimiselo eyongezelekileyo efana neemvavanyo zokuqinisekisa ukuba ungutata womntwana. Le Komiti ibikwanexhala lokuba icandelo 4 (3) leCitizen Amendment Act litolikwa ngendlela enyiniweyo uku libe lunched kuphela kubantwana abazelwe emva komhla woku-1 kuJanyuwari 2013, nto leyo eyenza unini lwabo bazelwe ngaphambi koko lubesemngciphekweni wokungabi nazwe.

Le Komiti icebise urhulumente ukuba:

- i. Aququzelele ukubhaliswa kwabantwana abazelweyo ngokwenza inkubo yokubhalisa ibe lula nokunceda abazali bafezekise imimiselo, ngokuthi umzekelo, abuyekeze iindleko zeemvavanyo zobungqina bokuba ngutata womntwana apho ezo mvavanyo ziye zabonisa ukuba ungutata womntwana; kwaye
- ii. Asebenzise imithetho yokuba ngummi ngendlela ebangela abantwana babazali abavela kumazwe angaphandle bangabi semngciphekweni wokungabi nazwe.

20. Ubudala obuvumelekileyo xa kutshatwa kunye nokwamkelwa ngokusemthethweni kwemitshato yamaMuslim

Le Komiti ibonise inkxalabo ngokungafani kobona budala bamkelekileyo bokutshata phakathi kwamakhwenkwe namantombazana, kananjalo nokungabiko komthetho owamkela imitshato yamaMuslim kunye nemiphumo yoku emibi kumabhinga ethe imitshato yawo yamaMuslim ayabhaliswa ngokusesikweni.

Malunga noko, le Komiti icebise urhulumente ukuba ondelelanise yonke imithetho efanelekileyo ukuqinisekisa ukuba obona budala buncinci bamkelekileyo bamakhwenkwe namantombazana benziwa buhambelanemigangatho yamazwe ngamazwe. Ikwacebise ukuba urhulumente aququzelele ukwamkela imitshato yamaMuslim, ngeli xa ebonelela ngeendlela zokukhusela amalungelo amabhingga.

21. Izithethethe ezinobungozi: uvavanyo lobuntombi kunye nokuthwala

Nangona le Komiti ivuma ukuba icandelo 31 loMgaqosiseko likhusela amalungelo ezenkcubeko, ezenkolo kunye noluntu lwezeelwimi. Le Komiti ibonise inkxalabo malunga nefuthe ebantwaneni lezithethethe ezifana novavanyo lobuntombi kunye nokuthwala, okuthi, xa loo ntombazana ingavumanga ukuthwalwa, kujongwe njengenye yeendlela zokuthengisa ngabantu.

Le Komiti icebise urhulumente ukuba alwe izithethethe ezinobungozi, ezifana nokuthwala kunye novavanyo lobuntombi, kuukua ngokwandisa ulwazi lwefuthe elibi lwezi zithethethe emantombazaneni nakumabhingga ubomi bawo bonke, kwaye aqinisekisa ukuba ezo zithethethe zipheleiswe kwaphela.



22. Ukungondleki kwabantwana kunye nelungelo lokutya okwaneleyo

Le Komiti ibalule ukungabikho komthetho wokuqinisekisa ilungelo lokufumana ukutya kwakunye nokuxaphaka kokungabikho kokhuselko lokutya kunye nokungondleki kweli lizwe, ingakumbi apha ebantwaneni. Le Komiti ibonise inkhalabayo yokuba isibonelelo sokuxhasa abantwana (esingama-400 eerandi ngenyanya) singaphantsi komgangatho wentlupheko kwaye ne-18 pesenti yabantwana abafaneleyo abasifumanesi sibonelelo, ngenxa yokungabi nazimpepaha. Xa ibona oku, le Komiti icebise urhulumente ukuba:

- i. Anyuse isibonelelo senkxaso yabantwana ubuncinane sifike kwinqanaba lomgangatho wentlupheko;
- ii. Aqinisekise ukuba bonke abantwana abafaneleyo bafumana isibonelelo;
- iii. Anyuse umgangatho wezbonelelo zenkxaso yabantwana ngabantwana abaziinkedama nabalahliwego abahlala nezizalwane; kwaye
- iv. Athathe umthetho okhusela ilungelo lokutya okwaneleyo kunye nokondleka, aze aphuhlise iqhinga lomsebenzi likazwelonke lokhuselko lokutya nokondleka.

23. Ilungelo lokufikelela kwizindlu ezifanelekileyo

Le Komiti iyivuyele imizamo eyenziwa ngurhulumente yokubonelela ngezindlu zikarhulumente kwiintsapho ezinemivuzo emincinci. Kodwa ke le Komiti, isenexhala:

- i. Ngobuninzi babantu abahlala ezindlwini ezingafanelekanga, kuquka nabo basematyotyombeni, ngaphandle kokufikelela kwiinkonzo ezisisiseko;
- ii. Ngokwanda kwamatyotyombe ezidolphini ngenxa yokukhawuleza kokuhula kweedolphu, nangokuhla kwenani lezindlu zikarhulumente ezibonelelwaa ngurhulumente;
- iii. Ngeengxelo zokukhutshwa ezindlwini ngokungekho mthethweni nokusetyenziswa kwamandla agqithisileyo ngexesa lokukhutshwa ezindlwini, kananjalo nokukhutshwa ezindlwini ngaphandle kokubonelela kukamasipala enye indawo yokuhlala; kunye
- iv. Neemeko ezimbi vezindlu nezokuhlala kwabo bahlala ezifama.


Le Komiti icebise urhulumente ukuba:

- i. Aphucule iimeko vezindlu kwaye ahlangabezane nokufuneka kwezindlu okwandileyo, kuquka ngokuhubeka ukubonelela ngezindlu zikarhulumente ezifanelekileyo ezidolphini nokuphucula iimeko vezindlu zasematyotyombeni;
- ii. Aqinisekise ukuba ukukhutshwa ezindlwini kwensiwa kuphela njengenyathelo lokugqibela, ngaphandle kokusetyenziswa kwamandla nangokuthobelaa imigangatho yamazwe ngamazwe; kwaye
- iii. Aphucule iimeko vezindlu nezokuphila kwabo bahlala ezifama ngokuwuthobelaa ngokupheleleyo uMnqophiso kunye neminye imigangatho yamazwe ngamazwe yamalungelo abantu, ingakumbi ummiselo wokuba abantu abakhutshwa ezindlwini mababonelelwae ngenye indawo yokuhlala efanelekileyo.

24. Ukucotha kwenkqubo yeenguqu yemihlabu kunye nokulinganiselwa kokufikelela kwimihlabu

Ukucotha kwenkqubo yeenguqu yemihlabu ibiyinto exhalabisayo kule Komiti, iphawule ukuba urhulumente uphanzile ukuhlangabezana neenjongo zakhe zokubuyisela abantu emihlabeni. Le Komiti ikwabonise ngenxalabo ngenkxaso engonelanga emva kokuhlawulwa nokungabikho koqegeesho lwabaxhamli bokuphinda kuhanjiswe komhlaba. Kananjalo okuxhalabisayo kule Komiti kukuba amabhingga ngabanini be-13 pesenti kuphela yomhlaba wezolimo kwaye asagxalathelene nocalucalculo ekufikeleleni kwimihlabu, ngenxa yezithethet zamasiiko amafa.

Le komiti icebise urhulumente ukuba akhawulezise ukuqaliswa kokuphinda kuhanjiswe imihlabu kunye ngenkqubo yokubuyiswa kwemihlabu aze abonelele abaxhamli ngenkxaso eyaneleyo ukuze basebenzise le mihlabu yenze imveliso kwaye bazibonelele ngendlela yokuphila. Le Komiti iqbekile yacebisa urhulumente ukuba aqinisekise ukuba amabhingga afikelela ngokulinganayo emhlabeni nakubunini bemihlabu.



25. Ukufikelela kwezempilo ezifanelekileyo

Nangona le Komiti iphawulile ukuba uMzantsi Afrika uzama ukufikelela kukhuselo lonakekelo Iwezempilo jikelele ngokuthabathela iNational Health Insurance Bill, le Komiti ibinexhala negeyantlukwano enku phakathi kweenqubo zonakekelo Iwempilo zikarhulumente nezabucala, ibe inkqubo karhulumente isilela mayelana nenani leengcali zezonyango, izixhobo zezonyango, inkcitho yezonyango, kwakunye neyantlukwano yokubhalisa kwiNational Health Insurance Fund phakathi kweendawo ezesemaphandleni nezisezidolphini kunye nokufikelela kwiinkonzo zonakekelo Iwempilo. Nangona le Komiti iphawule inkqubela eyenziwego ekwenzeni unyango lwee-antiretroviral lufikeleleka kwizigulanane ezineHIV, le Komiti ibinexhala lokuba izigulanane ezinini azikakwazi ukufikelela kolu nyango.

Le Komiti icebise urhulumente ukuba:

- i. Akhawulezise ukuthatyathelwa kweNational Health Insurance Bill;
- ii. Aqubisane neyantlukwano enku phakathi kweenqubo zonakekelo Iwempilo lukarhulumente nezabucala, kwakunye naphakathi kweendawo ezesemaphandleni nezisezidolphini, ngokufumana inani elaneleyo leengcali zezonyango, ukuphucula izixhobo zezonyango; kunye
- iii. Nokuqinisekisa ukuba bonke abantu abadinga unyango olusindisa ubomi bayafikelela kumayeza afikelelekayo ngokwasemalini, ingakumbi amayenza ii-antiretroviral kubantu abaphila nentsholongwane iHIV.

26. Ukufikelela kunakekelo Iwempilo yezesondo nezenzalo

Le Komiti ibonise ixhala lokuba mbalwa kwamaziko onakekelo Iwempilo abonelela ngeenkonzo zokukhupa iizisu, kunye nokunyineka kokufikelela kwiindawo ezbionelela ngezi nkonzon, ingakumbi kwiindawo ezesemaphandleni. Kananjalo okuxhalabisayo kule Komiti kukuphakama kwamanani okukhulelwaa kwabasafikisayo, nokukhokelela kwinani eliphezulu lokuyeka phakathi esikolweni kwamantombazana.

Xa ibona ezi nkxalabo zingentla, le Komiti icebise urhulumente ukuba:

- i. Iindawo kunye neenkonzo zempilo yezesondo nezenzala, kuquka nezokukhupa iisu, mazifumanekwa zifikeleleka kubo bonke abantu, ingakumbi kwiindawo ezesemaphandleni.
- ii. Oogqirha abalayo ukukhupa iisu ngengxa yezazela zabo kumele bagqithisele abantu kwabanye oogqirha kwakule ndawo yabo okanye kwenye indawo ekufutshane ukuze oku kwala kwabo kungami endleleni yokufikelela kwamabhingga kwiinkonzo zokukhupa iisu;
- iii. Athobe amanani aphakamileyo okukhulelwaa kwabasafikisayo kwaye aqinisekise ufikelelo nokufumaneka kolwazi malunga nempilo yezesondo kunye neyenzala kunye nocwangcionsapho kumntu wonke, kuquka namantombazana namakhwenkwe asafikisayo, ingakumbi kwiindawo ezesemaphandleni; kwaye
- iv. Abonelele ngeenkonzo zenkxaso ezifunekayo kumantombazama afikisayo akhulelwego, kuquka namanyathelo okuwavumela aqhubekeke neemfundo yawo.



27. Isimo sezinto ezisetyenziswa zizikolo kunye nefuthe lazo kwilungelo lokufunda

Enye indawo exhalabisayo kule Komiti sisimo sezinto ezisetyenziswayo zizikolo. Imiba exhalabisayo iquka:

- i. Isimo sezinto ezisetyenziswayo zizikolo zikarhulumente ezingekho semgangathweni jikelele;
- ii. Iqela lezikolo lifikelela ngokunyiniweyo emanzini okanye alifikeleli kwaphela emanzini, kwiindawo ezipithoyilethi okanye umbane; ngenxa yokusikwa kolwabiwomali kunye nokupathwa kakubi kwemali, ngamanye amaxesha;
- iii. Amanani aphakamileyo okuyeka kwabantwana esikolweni, ikakhulu ngenxa yeziseko zokufunda ezibuthathaka;
- iv. Isithethe sokubizwa kweentlawulo zesikolo ngendlela yemirhumo enganyanzelekanga kwizikolo ezingahlawulisiyo, kunye nefuthe elicalucalulayo lokungahlawulisa imali yesikolo kwizikolo ezihlawulisayo, ingakumbi kubantwana babazali ababodwa;
- v. Ukungabikho kweengcebiso ngendima kunye noxanduva lweenkampani zabucala kwimfundu; kunye
- vi. Nokuthatha inxaxheba okungephi kwabantwana abasuka kumakhaya anemivuzo emincinci kwimfundu yabasebancinci, nangona urhulumente esenza iinzame.

Le Komiti yenze iqela leengcebiso, ejijolise kwimfuno yokuba urhulumente:

- i. Aphucule izinto ezisetyenziswayo zizikolo aze aqinisekise ukuba zonke izikolo ziyafilela emanzini, kwiindawo zeethoyilethi nasembaneni ngokunikezela nokupathha imali esemgangathweni owaneleyo.
- ii. Athobe inani lokuyeka kwabantwana isikolo ngokuphucula ukufunyanwa kwezakhono eisisiseko zokubala nezokufunda;
- iii. Aqinisekise ukuba izikolo ezingahlawulisiyo ziyayeka ukubiza abazali iintlawulo aze ahlakiye imimiselo yokungahlawulisa kwabathile kwizikolo ezihlawulisayo, ngenjongo yokuqinisekisa ukuba abantwana abahlelelekileyo abacalucalulwa;
- iv. Aphucule imithetho yolawulo ukuze acacise iindima kunye noxanduva Iwamashishini ezikolo zabucala, kwaye abeke esweni imfundu ebonelelwa zezi zikolo;
- v. Aqinisekise imfundu yabasebancinci yezinga eliphezulu kubo bonke abantwana, ingakumbi abo bavela kwiintsapho ezihllelelekileyo.



28. Ukufikelela kwimfundu kwabantwana abakhubazekileyo, abavela kumazwe angaphandle, abaziimbacu nabacela indawo yokuzimela

Kuye kwagxilwa nangakumbi kumzabalazo wabantwana abakhubazekileyo. Le Komiti ibinexhala lokuba abantwana abaninzi abakhubazekileyo abahambi isikolo kwaye aba bantwana, ingakumbi abo bavela kumakhaya anenivuzo emincinci, abazuzi kwizikolo ezingahlawulisiyo. Le Komiti iye yaqhubeka nokubonisa ukuxhalaba ngobuninzi babantwana abavela kwamanye amazwe, nabaziimbacu nabacela indawo yokuzimela abangabhaliswanga ezikolweni ezisesikweni.

Kwakujongwa le nkhalabo ingentla, iKomiti icebise urhulumente ukuba:

- i. Anwenwise ukuqalisa kwenkqubo yezikolo ezingahlawulisiyo kwizikolo eziphethwe nguRhulumente zabantwana abakhubazekileyo abangkawaziyo ukuncedwa kwizikolo zikawonkewonke;
- ii. Aqinisekise ukuba imfundu equka wonke umntu yinkolelo esisikhokelo kuzo zonke izicwangciso kunye neenkqubo zemfundu, kuquka nokubonelela ngeendawo zokuhlala ezamkelekileyo zabantwana abakhubazekileyo; kwaye
- iii. Aqinisekise ukuba bonke abantwana abavela kwamanye amazwe, nabaziimbacu nabacela indawo yokuzimela bayafikelela kwimfundu nokuba sithini na isimo sabo sokufudukela kweli.

29. Ukhuselo Iweelwimi zemveli zeli

Ukungabikho kokhuselo Iweelwimi ezisecinicini lokuphela kanye nokungabikho kokufundisa ngeelwimi zemveli zeli kanye neenkqubo zolwazi kwiinkqubo zezikolo zikarhulumente ibiyinto exhalabisayo kule Komiti.

Le Komiti icebise urhulumente ukuba:

- i. Akhusele iilwimi ezisecinicini lokuphela kwaye aqinisekise ukuba iilwimi zemveli zeli kanye neenkqubo zolwazi ziyafundiswa kwiinkqubo zezikolo;
- ii. Omeleze umyalelo weBhodi eQua iiLwimi zaseMzantsi Afrika (Pan South African Language Board) mayelana noku.

30. Ukuqinisekisa ukufikelela nokufikeleleka ngokwasemalini kwe-intanethi

Le Komiti ibonise inkhalabo ngokunyineka kokufikelela kwi-intanethi, ingakumbi kwiindawo ezisemaphandleni nasezikolweni, kwakanye nokungabikho kwamaxabiso afikelelekayo okungena kwi-intanethi koninzi lwamaqela ahlelelekileyo. Le Komiti icebise urhulumente ukuba athabathole kuye amanyathelo afanelekileyo ukuqinisekisa ukufikelela nokufikeleleka ngokwasemalini kwe-intanethi, ingakumbi ezikolweni nakwiindawo ezisemaphandleni nakuninzi lwamaqela ahlelelekileyo.

31. Ezinye iingcebiso

Le Komiti iye yenza kananjalo neqela leengcebiso kurhulumente, ezibalulekileyo kuzo zigxile kwisidingo sokuba urhulumente:

- i. Avume uMgaqo oNganyanzelekanga woMnqophiso waMazwe ngaMazwe waMalungelo eZoqoqosho, eZentlalo kunye neNkcubeko;
- ii. Avume iSivumelwano saMazwe ngaMazwe soKhuselo Iwabo Bonke aBantu ekuPhelisweni ngeSinyanzeliso kunye neSivumelwano saMazwe ngaMazwe malunga noKhuselo IwaMalungelo abo Bonke aBasebenzi aBavela kwaManye aMazwe kunye naMalungu eeNtsapho zaBo;
- iii. Aqinisekise ukonwatylewa ngokupheleleyo kwamalungelo aqulathwe kuMnqophiso ekuqualisweni kwe-2030 Agenda for Sustainable Development (kwe-Ajenda yango-2030 yoPhuhiliso oluThwalekayo) kuzwelonke, ngoncedo nentsebenziswano yamazwe ngamazwe xa kuyimfuneko;
- iv. Athathe amanyathelo okuqhubeaka nokuphuhlisa nokusebenzisa izinto zokulinganisela ezifanelekileyo ekuqualiseni ukusebenza kwamalungelo ezooqoqosho, ezentlalo naweenkcubeko;
- v. Apapashe konke oku kuFunyanisiwego kwaGqitywa Ngako; kwaye
- vi. Abandakanye iKhomishoni yaMalungelo aBantu yaseMzantsi Afrika, imibutho engekho phantsi korhulumente kunye namanye amalungu emibutho yoluntu kulandelelo lokuFunyanisiwego kwaGqitywa Ngako nakwinkqubo yokubonisana kuzwelonke ngaphambi kokungeniswa kwengxelo elandayo yamaxesha athile.

Ngokuhambelana nenqubo yolandelelo lokuFunyanisiwego kwaGqitywa Ngako okuthatyathelwe yile Komiti, uMzantsi Afrika kufuneka ubonelele, ngo-Okthobha 2020, ngenkcazelo yokuqaliswa kokusetyenziswa kweengcebiso eziphathelelene nokulungiselerwa kthesalathiso samalungu eendleko zokuphila nokufikelela kuncedo Iwezentlalo kubantu abadala abaminya ephakathi kwe-18 nama-59 ubudala, inkcazelo ephathelelene nokunyuswa okuphakanyiswayo kwesibomelelo sikarhulumente sabantwana-abaziinkedama nabahaliwego, kunye nenkcazelo ephathelelene nokufikelela kwimfundu kwabantwana abavela kwamanye amazwe, nabaziimbacu kunye nabacela indawo yokuzimela abangenazimphepa. Ukwaleka, urhulumente waseMzantsi Afrika kufuneka angenise ingxelo yakhe yesibini yamaxesha athile ngamanyathelo athathiwego ukuzalisekisa izibophelelo zakhe phantsi koMnqophiso ngomhla wama-31 ku-Okthobha 2023.


